Tabor gave updates on major projects, RFID and planning Pride programing.

# LIAISON REPORTS

Foundation – Foundation's audit is complete and the board will vote to accept at our next meeting on March 6<sup>th</sup>. They held a program on Sat. Feb. 25<sup>th</sup> launching Pulitzer-prize winning author Alison Lurie's posthumous young adult novel, *The Cat Agent*. This was organized by her late husband, Edward Hower, who made copies of the book available to guests with a donation to the Foundation. Over 40 people were in attendance and \$1,300 was raised. The Rosen Fund grant for Summer Reading Program funds has been submitted.

Barnes was proud to accompany Leslie Tabor to a "Meet the Director Q&A" at Kendal on Feb. 20<sup>th</sup>. Leslie was well-received by the crowd, who asked good but tough questions. I received a letter afterward from a major donor who attended who was full of praise for Leslie and her enthusiasm for TCPL.

The 11<sup>th</sup> Annual Readathon is approaching on April 15th. This year, like last, will be a hybrid event with both in-person and pre-recorded video readers. They are thrilled to have a team of young people from GIAC who are sponsored by Friends of Henry Granison this year (thank you Amanda and fellow legislators.) The Foundation board is donating to sponsor a TCPL staff team this year. Trustees are invited to join our board in contributing to covering the fundraising obligation for our library team.

Friends – There is a lull in donations at the moment but it is allowing us to shelve all the books.
