DIRECTOR'S REPORT

S. Currie welcomed Linda Bartnik, our newest trustee who was approved at last week's Government Operations Meeting. We will schedule an orientation, although she is very familiar with the library as a long-time volunteer, caring for the gardens around the building. And she was a public supporter in 2017 when S. Currie presented the library budget to the county.

Finger Lakes Library System's Annual Meeting: a meeting of the board reps from the 33 libraries of the system. We are required to have at least one member as there are items to be voted upon at the meeting. L. Chabot and C. Brewington will be attending the meeting.

Currie gave an update on the Business Manager Search, the search committee consists of Department Heads, Administrative Manager, Communications Manager and Laura Krauss from the board. The committee interviewed the top two candidates included time with Principal Account Clerk and the Foundation Director, In process of checking references.

- S. Currie thanked our Principal Account Clerk, Connie Clark, for her hard work while we are without a Business Manager. She is working hard and keeping everything running smoothly.
- S. Currie's presentation to the County is scheduled for Thursday, September 25 at 6:30 pm in legislative chambers. You can watch it via the legislative Youtube channel. Currie is pleased that Board Treasurer, Lis Chabot will accompany Currie. The budget proposed for TCPL is \$4,032,448 for 2026. She will be asking for one over target request for one Clerk and one Sr. Clerk for materials processing. The amount is \$96,570.00. Currie also sent requests to the Town and City of Ithaca, asking for \$15,00 from each as was granted last year. The funds would be used to support programming.

SEARCH COMMITTEE UPDATE

S. Clausen reported on behalf of the Director Search Committee, one of our candidates declined. The Committee worked through various options and are arranging to meet with Tompkins County Human Resources and the County Attorney.

LIAISON REPORTS

Friends – N. Scholtz announced the fall booksale starts October 11th and the friends are very busy getting ready. Library days are coming up. Donations are being accepted starting November 15th.



Large Type

Our Large Type collection continues to increase in circulation. Compared to this time last year, Large Type Fiction – NEW is up 40.57% and Large Type Non-Fiction

NEW 80.95% and this is after we saw an increase last year after supplementing the collection with additional funds.

Book Clubs with CARS

Asia and Judd visited the Cayuga Addiction Recovery
Services for 3 weeks of book clubs funded by the Finger
Lakes Library System's Outreach Mini-Grant. These
discussions are always amazing with the readers offering
keen insights into the readings, linking whatever we read to
both other works and to lived experiences. The first round
of visits was so popular that word got out and this time we
had an average of 12 people per session, discussing the
books *The Never Game* by Jeffrey Deaver and *All Systems Red* by Martha Wells.

Vendors

We have had supply issues with Baker & Taylor, our main book vendor, for most of this year, but the company has finally announced that they are officially shutting down January 2026, after almost 200 years of business. We were prepared and had begun setting up accounts with another vendor, Ingram, in April when signs of supply problems were showing. Setting up this processing is almost complete and in the meantime, books have continued to be available for our patrons thanks to the tireless work of the Technical Services Team.

Circulation Board Report - October 2025

Lobby Desk Service

We answered **1,347 questions** at the Lobby Desk since our last Board report, and **216 questions** during Outreach visits. Of those questions, **76 were compliments!** Here is a sample of questions and comments we've received:

- From our weekly Kendal Delivery driver: "you did a great job with [the Halloween decorations]. It reminds me of my childhood!"
- Patron excited about our Library of Things passes: "My daughter is coming to town this weekend, I'm so excited to go here together!"



- Another patron happy about Library of Things: "Isn't this nice? They have all sorts of passes and games."
- Two new patrons came in for library cards and said, "we live out in the county, so the hardest part is getting here." When we told them about our digital services, such as Libby, Hoopla and Kanopy, they asked "Really?!" We signed them both up for all three services on the spot!
- A patron happy with our compassionate service commented, "these are the get-out-of-jail people, they remove our fines!"
- A patron happy with our new delivery service to McGraw House chatted with staff about a book they were able to get through Interlibrary Loan with photographs and accompanying poems that they discussed in a poetry group at McGraw House, and placed new holds on more books!
- "I love your library, by the way. I know it has changed since I lived here when I was in 7th grade, but it still feels wonderful."
- "I haven't been here in a really long time, but I just started reading again, it feels really important right now."
- "I visit libraries wherever I visit, this is number 68. My home library system had a road trip adventure thing and I did it twice and now I have a platinum library card. If I lost my wallet I'd be more upset about losing that than my credit card."
- Patron came to use the Schwarz Jacobson room, shared that they are working with DSS, doing nature therapy and "echo" therapy, said they are really glad to be able to use and reserve the space, since the "atmosphere at DSS is not conducive to this kind of therapy."
- A patron asked, "can i take a few of these [harm reduction] stickers for my kids?" and added, "this is much needed, this positivity."

Outreach & Programming

• Community Libraries Update

 The Caroline Reading Room circulated 75 items in September, 8% of their total came from TCPL's collection. The Danby Community Library circulated 84 items in September, 12% of their total came from TCPL's collection.

Banned Books Week Giveaway Program

 Mel reports that the "Adopt-a-Banned Book" giveaway was a roaring success, with all 57 challenged books finding new homes within the day. Ally & Mel carefully selected and wrapped each book in brown paper, with a simple card stating the audience, and the reasons they were banned or challenged. Without being able to see the cover, title or author, patrons could guess what book they would unwrap.

Delivery Service to McGraw House! We finished our first month of twice-

 weekly deliveries to McGraw House! One patron is delighted that we are willing and able to deliver the Library of Things' sewing machine this winter, so she can continue to craft when it's too cold, snowy and icy to brave the sidewalks to TCPL.

 reported that when they were introduced to the lunch group, they talked about the
 Friends of the Library Book Sale, and the diners cheered and clapped! "It felt like a
 movie," says Ally.
- YMCA Trunk or Treat: A collaboration with Youth Services! On Saturday, October 18,
 Tom decked out his Nissan and he and Sasha handed out candy to ~503 visitors!
- Foodnet Meals on Wheels at Titus Towers: Mel and Katylyn visited Titus Towers on October 22 and visited with about 20 residents.
- Mood Elevating Creative Expression Workshop with Yael Saar: Mel worked with Yael on this art program on October 22, which quickly reached capacity! Patrons "learned to use art to gently shift nervous system states from stress to creativity while fostering self-trust." Techniques included "Bilateral Doodling," "Color Boundary Markers," and "Zero-Barrier Art."
- Friends of the Tompkins County Public Library Book Sale!: Ally worked at FOL Sale on October 22, gathering material for social media and marketing, and connecting with shoppers and Friends alike. Thank you, Ally!
